

President's Message

During the past year there has been a lot of controversy over a proposed new Administration Building. Some of you are new residents in Leisure World and some of you have been on the periphery of what has been going on. My intent is to provide you some background and where we are now.

In 2017–18 after three years of planning, Leisure World presented a site development plan to the Montgomery County Planning Board, which controls and governs construction in the county. previous During the three comprehensive review was made on the lack of working space needs for staff in the current Administration Building, bringing the existing administration building up to safety standards/ codes, expanding the size of the building, and as an alternative, building a new, modern facility at a different location. The choice was to construct a new Administration Building and demolish the current, 50-year-old one.

The comprehensive site development plan for the new Administration Building included for Clubhouse I upgrades recommended by the residents. The site of the existing Administration Building would be converted into close-in handicaped parking for Clubhouse I, which was also desired by our residents.

In 2019–20, after approval by the Montgomery County Planning Board, the Leisure World Board contracted for detail engineering specifications and solicited bids for construction. This past fall a construction company was picked for the work package and the necessary permits were applied for. When a vote was called to award the contract, it failed by one vote. Funding the project was not an issue as the community was reserving funds for it and the residents had already paid for it through a resales fee when they purchased their units. Board members who voted against implementing the plan wanted to revisit refurbishing the existing Administration Building or building a new one at the current location.

The Leisure World Board is currently looking at funding a company to again evaluate whether the existing Administration Building can be brought up to current safety standards/codes, and whether management staff can be

January Board Actions

The VPE Board agreed to:

- the Shapiro & Duncan's Standard Maintenance PLUS contract to service the common area units over a three-year period at a cost of \$6,696.00 annually PLUS \$2,500.00 for repairs, payable: \$2,299.00 per quarter. Funds to come from Replacement Reserves.
- the LWMC Invoice in the amount of \$2,210.32 for replacement of an exhaust fan. Funds to come from Replacement Reserves.
- the Dynalectric proposal in the amount of \$4,420.00 to remove and install four new Siemens bucket switch mounting plates that would require a power shutdown for approximately 4-8 hours. Funds to come from Electrical Maintenance.
- the Shapiro & Duncan's HWH Maintenance addendum to the Preventive Maintenance Agreement in the amount \$1,236.00 per year to add the two Lochinvar boilers. Funds to come from Hot Water Heater Account.
- appointment of Kathi Carlson to the Communications Committee.

accommodated at the current building location in lieu of building a new modern building.

With the delay of the overall project relative to the Administration Building, the LW Board is also looking at just awarding a contract for the Clubhouse I upgrades, which would consist of addition of a Terrace Room vestibule with an exterior canopy, addition of a circular driveway in front of the Terrace Room with handicapped parking, rebuilding of the loading dock area, and expansion of the Maryland Room to to accommodate more residents.

FebruaryBoard Actions

The VPE Board agreed to:

- approve the proposal from Engineering and Technical Consultants, Inc. for design and bidding services for the façade rehabilitation project at a cost not to exceed \$9,500. Funds to come from the Replacement Reserves.
- approve the proposal from Schindler Elevator Corporation to replace three governors, encoders and safety switch at a cost not to exceed \$21,000. Funds to come from the Replacement Reserves.
- request payment in the amount of \$5,000 from unit 1005 for the insurance claim for water damage originating in the unit. The Property Manger is authorized to make payment to LWMC when the invoice for the insurance deductible is received.
- approve the following new rule for distribution to unit owners for a 15-day review:
 - 13.12 Residents with electric or plug-in hybrid vehicles are permitted to charge their vehicles on a 120v outlet in the garage if they own an indoor parking space, pay for the electricity, can access an outlet, and agree to the policies and standards outlined in an agreement available from the Association Office.
- introduce a new Policy Resolution No. 7: Use of Electricity to Charge Electric/Hybrid Vehicles and notify unit owners of intent to approve with the final hearing to be held at the next regularly scheduled Board meeting.

You may have read my article in the *Leisure World News* that in a community like ours an 18-hole golf course increases residential property value between 20 and 40 percent. Put another way by decreasing an 18 hole golf course to 9 holes decrease the added value also by half. Currently our golf course is one of the few recreational amenities available that has a strong revenue stream. Last year Leisure World golfers played 20,585 rounds of golf and it is estimated that golf revenue could hit \$500,000 in 2021. Now is the time to start thinking about what your golf plans might be in 2021.

Moving to a new neighborhood can be both exciting and challenging. Doug and I moved to VPE from Denver in October 2019, and it took months before everything was unpacked and set up to our satisfaction. Then, of course, there was time spent discovering where to shop for groceries, which restaurants have the best takeout, looking for brunch places, finding a hair dresser, a barber, a dentist and other medical practitioners, and on and on. This all takes time and patience. The former I have in abundance, but the latter—not so much.
